- ***John Lowe v Keble Heath Construction Limited (2025 hearing) 1301828/2023*** successfully defended claims of automatic unfair dismissal and whistleblowing detriment: withdrawal of all claims following the conclusion of the Claimant's evidence.

- ***F. Manshausen v IMI Precision Engineering Ltd (2024 hearing) 1301744/2022*** Successfully represented the Claimant in a 7-day disability discrimination and victimisation claim concerning detrimental treatment of an employee during and after sickness absence for cancer treatment.
- ***Z v HRS Family Law Solicitors Ltd (2024) 1301745/2023*** Acted for the Respondent law firm in a sensitive disability discrimination claim arising from the performance management of a solicitor suffering from alcoholism.
- ***Adjei-Dawkins v Halfords (2023) 3300349/2021*** Defended the national retailer in a 7-day race harassment claim.
- ***Austin v Kingspan (2023) 1307462/2020*** Represented the Claimant in a 5-day disability discrimination and unfair dismissal hearing against a major manufacturing company.

The case involved a large-scale management reorganisation and established that the imposition of unmanageable new roles amounted to a repudiatory breach of contract.
- ***Hare Wines Ltd v Kaur & Anor [2019] EWCA Civ 216*** Represented the successful Claimant at first instance, in the EAT, and in the Court of Appeal in a key case concerning the proper application of the TUPE ‘sole or principal reason’ test.
